1 Having considered Plaintiff Alcon Entertainment, LLC (“Plaintiff”) and
2 Defendants Tesla, Inc. (“Tesla”), Elon Musk, and Warner Bros. Discovery, Inc.’s
3 (“WBDI’s”) Joint Stipulation for an Order Setting a Briefing Schedule for Tesla and
4 Musk’s Motion to Dismiss and Staying the Deadline for WBDI’s Response to
5 Plaintiff’s Third Amended Complaint (the “Stipulation”), and good cause appearing,
6 it is hereby ORDERED as follows:

- 7 1. The Stipulation is GRANTED.
- 8 2. Tesla and Musk shall file their motion to dismiss the First Claim for
9 Relief in the Third Amended Complaint by December 15, 2025; Plaintiff shall file
10 its opposition brief by January 7, 2026; and Tesla and Musk shall file their reply by
11 January 15, 2026.
- 12 3. WBDI’s deadline to file a responsive pleading to Plaintiff’s Third
13 Amended Complaint (Dkt. No. 81) is hereby stayed until this Court has heard and
14 decided Defendants Tesla, Inc. and Elon Musk’s forthcoming motion to dismiss the
15 First Claim for Relief in the Third Amended Complaint, subject to that condition
16 that in the event the Court’s decision on Tesla and Musk’s forthcoming motion to
17 dismiss does not moot Plaintiff’s Second Claim for Relief against WBDI, WBDI
18 will respond to the Third Amended Complaint in the form of a responsive pleading
19 (*i.e.*, an answer, rather than a separate motion to dismiss).
