24 ¹ In connection with the Parties’ meeting and conferring regarding Anthropic’s forthcoming motion
25 for summary judgment, Publishers informed Anthropic on April 19, 2026 that Publishers did not
26 intend to proceed on Counts II and III, and requested that Anthropic stipulate pursuant to Fed. R.
27 Civ. P. 15(a)(2) to their voluntary dismissal of Counts II and III with prejudice. To date, Anthropic
28 has declined to do so. Publishers have requested to meet and confer further with Anthropic and, if
Anthropic maintains its refusal to agree to Publishers’ proposed stipulation, Publishers intend to
move this Court for leave to amend their Complaint to remove Counts II and III pursuant to Fed.
R. Civ. P. 15(a)(2) once they have satisfied their meet and confer obligations under Sec. VIII.A of
the Court’s Standing Order.
